**READ WAIVER, IMAGE RELEASE AND RELEASE OF LIABILITY CAREFULLY**

I, the undersigned, am aware that during the Rappel or Climb and any meeting/practice and/or event with which I am participating in under the arrangements of Extreme Rappels LLC/ Agents/Associates/Participants/Event Companies/Organizers/Spectators; certain risks and dangers may be present or occur, including, but not limited to death by exposure, fall, equipment failure/breakage, personal neglect, hiking/backpacking, altitude, animal attack, personal accident or illness and travel on public and private roads, and all known and unforeseeable risks associated with Rappelling and Ascending in uncontrolled and controlled extreme environments in remote/inaccessible locations without medical facilities. I understand that self rescue and health care may be the only methods available at any or all times while participating in any event associated with an extreme sport. I further understand that due to additional and possible unforeseen factors present that I am taking a risk in participating in an extreme sport and that I am knowledge and qualified in this type of sport, and that I am in good condition and physical health, to participate.

In consideration and as part payment for the right to participate in such Extreme sport and associated activities and services arranged for me by Extreme Rappels LLC/ Agents/Associates/Participants/Event Companies/Organizers/Spectators, I have and do hereby assume all the above and other related risks which may be encountered on said Extreme Event including activities prior and subsequent to the Event and I do hereby indemnify and hold Extreme Rappels LLC/ Agents/Associates/Participants/Event Companies/Organizers/Spectators, harmless from any liability, actions, causes of actions, debt claims and demands of every kind and nature whatsoever which I now have or which may arise from or in connection with the Event or participation in any other act related there to. Extreme Rappels LLC/ Agents/Associates/Participants/Event Companies/Organizers/Spectators, are not responsible for personal injuries, any defect in another manufacture's product, loss or damage to any personal gear, loss or damage suffered by any person traveling to the location of the event, before during or after the event for any reason whatsoever including negligence on the part of Extreme Rappels LLC/ Agents/Associates/Participants/Event Companies/Organizers/Spectators.

I will act and follow all necessary protocol associated with an Extreme sport and conduct myself in a professional, safe and courteous manner at all times. I acknowledge that it is my responsibility to be able to perform such an event in a safe and controlled manner. I hereby grant Extreme Rappels LLC, all rights & use of all media, still or moving taken for/during an event and those acting with his/her authority and permission, the irrevocable and unrestricted right and permission to copyright, in his/her own name or otherwise, and use, re-use, publish, and re-publish photographic/video portraits or pictures of me on in which I may be included, in whole or in part, or composite or distorted in character or form, without restrictions as to changes or alterations, in conjunction with my own or a fictitious name, or reproductions thereof in color or otherwise, made through any medium at his/her studios or elsewhere, and in any and all media now or hereafter known for illustration, promotion, art editorial, advertising, trade, or any other purpose whatsoever. I also consent to the use of any printed material in conjunction therewith.

I hereby waive any right that I may have to inspect or approve the finished product or products and the advertising copy or other matter that may be used in connection therewith or the use to which it may be applied.
